A BILL

FOR AN ACT TO AMEND THE CUSTOMS TARIFF ACT 1986

ENACTED by the Parliament of the Republic of Fiji—

Short title and commencement

- 1.—(1) This Act may be cited as the Customs Tariff (Budget Amendment) Act 2020.
- (2) This Act comes into force on 18 July 2020.
- (3) In this Act, the Customs Tariff Act 1986 is referred to as the “Principal Act”.

Part 1 of Schedule 2 amended

2. Part 1 of Schedule 2 to the Principal Act is amended as specified in the table below, by deleting the duty rates in column 3 and substituting the new duty rates in column 4 for the following tariff items—

CUSTOMS TARIFF (BUDGET AMENDMENT) BILL 2020

EXPLANATORY NOTE

(This note is not part of the Bill and is intended only to indicate its general effect)

1.0 BACKGROUND

1.1 The Customs Tariff (Budget Amendment) Bill 2020 (**‘Bill’**) seeks to amend the Customs Tariff Act 1986 (**‘Act’**) to address budgetary policy changes in the 2020-2021 Budget.

2.0 CLAUSES

2.1 Clause 1 of the Bill provides for the short title and commencement. If passed by Parliament, the amending legislation will come into force on 18 July 2020.

2.2 Clause 2 of the Bill amends Part 1 of Schedule 2 to the Act to provide for the following changes to the tariff rates applicable under that Part—

- (a) duty on food items such as tomatoes, lettuce, cucumber, peanut butter, pasta, soya sauce, chocolate, vinegar, mixed condiments, soup and broth preparations, canned fruits such as pineapples, peaches, apricots, cherries, breakfast cereals, maple syrup, caviar, preserved fish such as salmon, herring, anchovies and beet sugar has been reduced from 32% or 15% to 5%;
- (b) reduction in fiscal duty on blankets, curtains, bed linen, table linen, kitchen linen, floor coverings such as carpets and linoleum, tableware and kitchen ware of wood, plastic flasks, wooden clothes hangers, multi-wick stoves, refrigerators, wall clocks, freezers, dry cleaning machines, washing machines, microwaves, toasters, coffee makers and cooktops;
- (c) reduction in fiscal duty on construction material such as building stones (granite, marble and travertine), flooring panels, ceiling fans and PVC fittings;
- (d) reduction in fiscal duty from 5% to 0% on new machinery such as cranes, winches, elevators and conveyors, bulldozers, loaders, graders, scrapers, pile drivers, mobile drilling derricks, concrete- mixer lorries and crane lorries;

- (e) reduction in fiscal duty on beauty related materials such as lipstick, eyeliners, eye shadow, facial powder, preparations for hair use (shampoo, conditioner and hair relaxers), manicure or pedicure preparations, complete wigs, fake eye lashes, hair curling wands, hair dryers, hair removing appliances and shavers from 10% to 5%;
- (f) reduction in fiscal duty from 10% to 5% on personal hygiene goods such as liquid bath soap, toothpaste, dental floss, toothbrushes, combs, perfumes and perfumed bath salts;
- (g) reduction in fiscal duty on baby walkers and swings, baby strollers, wheeled toys, exercise books and video games;
- (h) in addition to the reduction of the 75% specific duty on motor vehicles and allowing the importation of cheaper and quality petrol and diesel vehicles, the age restriction of 5 years or less has been removed on the importation of diesel and petrol vehicles however, the 5 year requirement remains for hybrid vehicles. All vehicles imported into Fiji must be EURO 4 compliant;
- (i) reduction in the fiscal duty on white goods such as air conditioners, refrigerators and freezers, smart phones, televisions, washing machines, dryers dishwashers, electric stoves, microwaves, electric lawn mowers, toasters, electric jugs and hair dryers;
- (j) reduction in the fiscal duty on electronics such as headphones, digital cameras, radios, instant print cameras, surveillance cameras and video recording apparatus. Microphones, loudspeakers, headphones and earphones will now be duty free;
- (k) reduction in the fiscal duty to 0% for marine vessels such as inflatable rafts, fishing vessels, refrigerated vessels, dredgers, tugs and pusher craft and sailboats;
- (l) for entities that provide recreational activities to the tourism sector, the fiscal duty and import excise has been reduced to 0% on parachutes, paragliders, kayaks, balloons and dirigibles, gliders, hang gliders and other non-powered aircraft, helicopters and aero planes;
- (m) spas and swimming pools now attract free fiscal duty; and
- (n) domestic and imported alcohol excise duty have been reduced by 50%.

2.3 Clauses 3 and 4 of the Bill insert various concessions applicable under Parts 2 and 3 of Schedule 2 to the Act, including the following—

- (a) duty concession for the importation by a private individual will be extended to importation by sea freight in addition to the current air freight. The concession is further extended by increasing the maximum threshold of goods imported from \$400 to \$2,000;

- (b) concession code 231 will be extended to include the importation of innovative packaging materials at the rate of free fiscal, free import excise and 9% VAT; and
- (c) concession code 257 will be expanded to include the importation of hydroponic and greenhouse goods at the rate of free fiscal and free import excise and 9% VAT.

3.0 MINISTERIAL RESPONSIBILITY
