PARLIAMENTARY REMUNERATIONS ACT 2014 (Section 15(1)(b))

DETERMINATION OF THE PARLIAMENT OF THE REPUBLIC OF FIJI

PURSUANT to Section 15(1)(b) of the Parliamentary Remunerations Act 2014, I hereby publish the Determination of the Parliament of the Republic of Fiji in the Schedule. Pursuant to the Resolution of Parliament on 24 May 2024—

"(a) Parliament has made a determination to amend the salaries payable under Part A of the Schedule to the Parliamentary Remunerations Act 2014, as set out below —

Travelling Allowance For meetings of Parliament or Committee, if the member permanently resides at any place more than 30 kilometers away from the place of the meeting of Parliament or Committee, then the member shall be entitled to cost of travel by the most direct route by road if the member is accommodated away from their permanent residence, to and from the meeting. Allowances in respect of motor vehicles shall be payable at the following rates—
 - (a) Vehicles of up to and equal to 2000cc 50 cents per kilometre; and
 - (b) Vehicles of 2001cc or over 60 cents per kilometre.
 - 6. Maternity Leave
 - 7. Overseas Travelling Allowance UNDP subsistence allowance x 1.25.
 - 8. Parliamentary duty allowance \$15,000 per annum (Not taxable).

Travelling Allowance For meetings of Parliament or Committee, if the member permanently resides at any place more than 30 kilometers away from the place of the meeting of Parliament or Committee, then the member shall be entitled to cost of travel by the most direct route by road if the member is accommodated away from their permanent residence, to and from the meeting. Allowances in respect of motor vehicles shall be payable at the following rates—
 - (a) Vehicles of up to and equal to 2000cc 50 cents per kilometre; and
 - (b) Vehicles of 2001cc or over 60 cents per kilometre.
- 3. Committee Sitting Allowance For Committee sittings on days other than the sitting of Parliament, the member shall be entitled to an allowance of \$200.00 per day.
