## **Public Enterprise (Assets Fiji Limited) Regulations 2015**

IN exercise of the powers conferred upon me under section 38 of the Public Enterprise Act 1996, with approval of Cabinet, I make these Regulations—

*Short title and commencement*

1.—(1) These Regulations may be cited as the Public Enterprise (Assets Fiji Limited) Regulations 2015.

(2) These Regulations shall come into force on 13 November 2015.

*Transfer of Assets*

2.—(1) For the purpose of the Public Enterprise Act 1996, all interests in land currently owned or held by Fiji Ports Corporation Limited shall be vested in Assets Fiji Limited.

(2) For the purpose of the Public Enterprise Act 1996, all interests in land currently owned or held by Fiji Ships and Heavy Industries Limited shall be vested in Assets Fiji Limited.

(3) For the purposes of subsections (1) and (2), an interest in land includes a leasehold interest, easements right and a licence affecting land.
