

# PARLIAMENT OF THE REPUBLIC OF FIJI

# **MINUTES**

of Proceedings of Parliament at Suva on Thursday, Fifth day of September, 2024

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

# 3. ATTENDANCE

# 4. <u>CONFIRMATION OF MINUTES</u>

#### 5. COMMUNICATIONS FROM THE CHAIR

Hon. Speaker welcomed all Honourable Members to the sitting, those seated in the gallery and those watching the live proceedings on television and the internet.

The Hon. Speaker also extended a warm welcome to the 2024 Hibiscus Festival Contestants. The Hon. Speaker acknowledged the significance of the festival's revival after a lapse of five-years and hoped that the experience would not only educate the contestants but also raise awareness on the Parliament institution and promote women's representation in Parliament.

The Hon. Speaker commended the contestants for addressing important issues in the media and encouraged them to continue engaging in decision-making processes to effect positive change in their communities.

The Hon. Speaker reminded the contestants that only one would be crowned Miss Hibiscus, but urged the others to persevere and keep moving forward. He concluded by wishing the contestants well for the rest of the week's activities.

The Hon. Speaker informed all Honourable Members on the availability of the back-to-office report for the study visit that was undertaken at the Parliament of Victoria by the Public Accounts Committee and Economic Affairs Committee in the Library for their perusal and reference.

# 6. PRESENTATION OF REPORTS OF COMMITTEES

#### (a) Standing Committee on Economic Affairs

#### **Oral Questions**

- Hon. Naisa Tuinaceva asked the Minister for Public Works, Meteorological Services and Transport Can the Minister inform Parliament on how the Ministry plans to regularise private vehicles that are engaged in illegal public service activities.
- Hon. Ratu Rakuita Vakalalabure asked the Deputy Prime Minister and Minister for Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on the Farm to Fork initiative that is currently being spearheaded by the Ministry.
- Hon. Mosese Bulitavu asked the Minister for Housing and Local Government Can the Minister inform Parliament on the reasons why the Municipal Councils are not providing town base permits to vehicle owners application which have been accepted by LTA for the processing of their PSV permits in particular for LMs and LCs.
- 198/2024 Hon. Tomasi Tunabuna to ask the Minister for Education Can the Minister update Parliament on the Memorandum of Understanding between the Ministry of Education and China's Education Ministry.

- 202/2024 Hon. Jovesa Vocea asked the Deputy Prime Minister and Minister for Finance and Strategic Planning, National Development and Statistics Can the Deputy Prime Minister update Parliament on the proposed increase in student bus fares by the Fijian Competition and Consumer Commission.

203/2024 Hon. Shalen Kumar asked the Minister for Home Affairs and Immigration – Given the 94% increase in illicit drug cases recorded in January 2024, what specific measures is the Ministry implementing to combat the surge in drug trafficking and usage, particularly concerning methamphetamine and marijuana.

204/2024 Hon. Iliesa Vanawalu asked the Minister for Housing and Local Government – Can the Minister update Parliament on the Phase 2 of the National Housing Policy Review.

The responses to the Oral and Supplementary Questions were provided by the respective Ministers. The Hon. Speaker informed Honourable Members that Oral Question 198/2024 had been withdrawn.

#### 11. MOTION FOR DEBATE

The Deputy Prime Minister and Minister for Finance, Strategic Planning, National Development and Statistics the Hon. Prof. Biman Prasad moved a motion for the purpose of section 145(1) of the Constitution and pursuant to Standing Order 131, that Parliament approves –

- (a) the increase in Government guarantee limit for the Fiji Sugar Corporation Limited (**'FSC'**) borrowings of \$95.0 million for the period 1 August 2022 to 31 May 2028 (Guarantee Period), by \$105.0 million to \$200.0 million; and
- (b) that the FSC be exempted from paying the guarantee fee.

Motion seconded.
