## **MINUTES**

of Proceedings of Parliament at Suva on Monday, Twenty-fourth Day of February, 2025

- 1. The House met at 10.00 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

### 4. <u>COMMUNICATIONS FROM THE CHAIR</u>

Hon. Speaker welcomed all Honourable Members, the guests in the gallery and those watching the live broadcast of the proceedings. Hon. Speaker advised all Honourable Members that the Official Opening of the Third Session of the Parliamentary Term of the Fijian Parliament would be officiated by His Excellency Ratu Naiqama Tawakecolati Lalabalavu, *Na Gone Turaga Bale na Tui Cakau*.
